The Contract Documents that include, but are not limited to the drawings and specifications, may be obtained on or after 2:00 P.M. on Thursday, September 11th 2014. Documents are available Monday through Friday between the hours of 9am-5pm at 244 Fair Street – 3rd floor, Kingston, New York 12402.
